The Ueberroth's gift will enable Dr. Brooks to advance Hoag's Women's Health Institute in the areas of research, education and program development. This includes recruiting new physicians, increasing patient navigation resources and piloting innovative women's health projects.

Dr. Brooks' first objective with the endowment will make a transformational impact by establishing a women's health and wellness center. The center will be an integrated program combining preventative care, wellness resources and health services all under one roof. The dedicated women's center will serve women of all life stages, from all backgrounds, with diverse wellness goals.

"I am humbled to receive this remarkable honor from the Ueberroth family, and excited about what it will mean for women's health in Orange County," Dr. Brooks said. "As endowed chair, I am committed to accepting the great responsibility of delivering on our promise to keep Hoag a leading-edge clinical care provider and a pioneer in this collaborative approach to women's health."

Highest Honor

Endowed chairs are one of the most prestigious honors that can be bestowed on a physician. Bringing medical advances to our community, Hoag's endowed chair holders are as much leaders of care as they are providers of care. In a very tangible way, endowed chairs provide financial resources to fund innovative approaches and programs.

While historically associated with academic institutions, Hoag now has eleven endowed chair positions that are enabling the organization to expand and improve programs in cancer, cardiac care, memory loss and cognitive impairment, neurosciences, cardiovascular surgery, gastrointestinal disease, diabetes, breast care, and now women's health services.

The latest endowed chair marks the third at the Executive Medical Director level including:

Vision to Reality!

New Women's Health Center Will Provide Personalized, Innovative and Integrated Care

Imagine a special place dedicated to supporting women's optimal health and wellbeing. A resource designed by and for women that supports them through the myriad of issues, challenges and opportunities that make up a woman's life. Allyson Brooks, M.D., executive medical director, Women's Health Institute began imagining it in 2007.

Thanks to Ginny and Peter Ueberroth and other committed donors, Dr. Brooks, the first recipient of the Ginny Ueberroth Executive Medical Director Endowed Chair, Women's Health Institute at Hoag, is realizing that vision. The \$5 million endowment from the Peter and Ginny Ueberroth Family Foundation is the first of its kind in Orange County to benefit women's health and wellness.

"Allyson Brooks is changing things. She's looking at the whole woman and making services available that optimize health on all levels," says Ginny. "She is a verymuch-loved OB-GYN. She's out in the community and understands the needs of local physicians and how best to complement what they're providing."

Serving the Whole Woman

A top priority for Dr. Brooks is to launch a women's health and wellness center — an integrated program combining preventative care, wellness resources and health services in one convenient location. The center will provide assessment, education, guidance and medically-based integrated care to help women achieve excellent health. The proven therapies, specialized care and support services are accessible to women of all ages.

Women often have issues that aren't addressed during office visits. "A woman may not mention to her physician that she is stressed, in pain, depressed, sleep deprived or having an issue with her parents, children or spouse," Dr. Brooks shares. "The center will not replace a woman's relationship with her physician but rather act as an extra resource. Many physicians don't have all of the support services in their offices to fully address the variety of needs beyond the clinical. The women's center will work alongside a woman's physician to help fill the gaps."

Services and alternative therapies for medical conditions will be offered in collaboration with, and support of, the physician community. Leveraging an evidence-based, clinical approach to health and wellness, the women's health specialists work together with a woman's physician to augment her current care plan with its integrated services. It will assist and support women to reach their goals.

Hub for Healthy Living

Either referred by a physician or self-referred, women will find a comprehensive resource that supports them in maximizing their health and wellbeing on all levels. The women's health and wellness center will be designed as a one-stop shop for everything from making lifestyle changes to improving health. It will offer women support to enhance quality of life during a health challenge and thrive after recovery. Highlights of a few of the planned services include:

- OB education and lactation support
- Pelvic health services including physical therapy
- Specialty retail services
- Optimal wellness and prevention services
- Strength training and weight management
- Life stage management support for transitions and challenges from young adults to childbearing to menopause and beyond
- Professional assistance-treatment, guidance and referrals
- Health and lifestyle coaching including customized wellness toolkits, high-engagement programs and educational workshops
- Counseling for mental and behavioral health, sexual health and life transitions

Staff will include a variety of health professionals who will collaborate with women and their physicians to optimize health and quality of life:

- Nurse Practitioners
- Physician Assistants
- Physical Therapists
- Massage Therapists
- Acupuncturists
- Guided Imagery Specialist
- Clinical Psychologist
- Sex Therapist & Educator
- Health Coach
- Pilates Instructors
- Lactation Consultants
- OB Nurse Educators

Hoag's first women's health and wellness center, located in Hoag Health Center Newport Beach, is scheduled to open in early 2016. The 10,000 sq. ft. space is adjacent to community physicians including several OB/GYNs, Hoag Medical Group and the Mary & Dick Allen Diabetes Center.

The new center will expand services to Hoag patients and to women throughout Orange County. ■
