

### Featured Giving Opportunity:

#### HOAG FAMILY CANCER INSTITUTE Developmental Therapeutics Program

For patients whose cancer has not responded to standard treatments, or who have advanced disease, a drug in an early-phase clinical trial may offer new hope and healing. Traditionally, these early-phase “developmental therapeutic agents” are available on a very limited basis and only in specialized cancer centers.

Hoag Family Cancer Institute's exceptional reputation, as well as its alliance with USC Norris Comprehensive Cancer Center, positions it perfectly to develop a program that offers promising new therapeutic agents to our community before they are widely available. That means patients will have access to personalized treatment specific to the genomic profile of their individual tumors without leaving our community.

With the first trial beginning this spring, philanthropic support will be crucial in continuing implementation and ongoing sustainability. Funds will be used in the following ways:

- Closing the gap on the cost of clinical trials and reimbursement
- Upgrading clinical patient space in the Patty & George Hoag Cancer Center for the Phase I and Phase 2 Clinical Trials Unit and acquiring the necessary equipment
- Recruiting a specialized team

We are grateful to Marianne and Jim Nahin whose \$150,000 Nahin Family Cancer Center Fund is being used to start the ball rolling. # Happy Anniversary 552 Club!

**Celebrating 50 Years of Raising Friends and Funds for Hoag**

In 1966, the Hoag Memorial Hospital Presbyterian board of directors knew that the 75-bed community hospital, which had served coastal Orange County for 14 years, would soon be too small to meet the needs of a growing community. Hoag would need to expand to continue to be a relevant community resource. They made the decision to build a 10-story tower to accommodate additional services and patient rooms.

A group of concerned community leaders accepted the challenge of developing a plan to build community awareness of, and financial and

volunteer support for, Hoag's mission. After learning more about the hospital's plans, the group formed the 552 Club, named for Hoag's goal at that time of expanding to 552 beds. Active "membership" was granted to those who made a minimum annual contribution of \$100. The idea took hold and the rest is history.

Over the years, this community-based group of volunteers and donors was a magnet for drawing support for Hoag. 552 Club volunteers planned a variety of social and sporting events to raise friends and funds for Hoag including the Toshiba Classic

Golf Tournament, the Movie Screening event and the Christmas Carol Ball. As a result, the 552 Club has raised funds for every significant initiative undertaken by Hoag over the ensuing years.

Today's 552 Club is as vital as ever. Now, everyone who makes a \$100 donation or more each year is considered part of the 552 Club family of donors. The 552 Club is served by a passionate board and several volunteer committees that honor the traditions of the founders even as they find new ways to add value.

# Forward Motion

**Dr. James Caillouette, Joan & Andy Fimiano Endowed Chair in Orthopedic Surgery, Continually Innovates to Keep Patients Moving**

James T. Caillouette, M.D., Joan & Andy Fimiano Endowed Chair in Orthopedic Surgery, has a saying he shares with patients. Motion is life. Those words

not only define his work as an orthopedic surgeon who restores mobility to his patients, they fuel his personal mission to innovate the technology and delivery of orthopedic care.

After 28 years at Hoag, Dr. Caillouette remembers that when he first

joined the staff, Hoag saw less than 200 joint replacements a year. "Today, Hoag Orthopedic Institute performs thousands of joint replacements each year," he says. "I've had an opportunity to participate, along with my colleagues, in growing this institution and it has been very rewarding."

Andy and Joan Fimiano, who were both treated several years ago by Dr. Caillouette, established the endowed chair to recognize and honor the physician for his work in health care economics and reform, along with the design of next-generation hip and knee implants. "The goal of our gift is to enable Dr. Caillouette to share his expertise so that it benefits more people. Basically, we need to clone him," Joan says with a smile.

The proceeds from the endowed chair will enable Dr. Caillouette, chief strategy officer of Hoag Orthopedic Institute, to expand outreach, education, research and innovation. The Fimiano's generosity gives him and his team the opportunity to introduce more process innovations such as bundled payment, a new payment model Hoag Orthopedics introduced in 2008. With proven success, Medicare adopted this payment system for total hip and knee replacement. It is anticipated that bundled payment will ultimately be applied to most interventional specialties.

For their part, the Fimianos are very pleased to support Dr. Caillouette and his important work. "We are so grateful to have the opportunity to recognize Dr. Caillouette, one of the finest orthopedic surgeons in the region," Andy says. "Joan and I know Dr. Caillouette will use his endowed chair as a platform for expanding his research and recruitment and, most important of all, for improving treatment and outcomes for Hoag's patients."

# Healers Who Give

**Physician Leaders at Hoag Orthopedics Open Doors to the Future Through Giving and Service**

Hoag Orthopedics physicians have collectively made more than \$680,000 in gifts to develop a self-sustaining institute that continually drives improvements in patient care, research, education and innovation. In fact, more than half of Hoag's orthopedic physicians contribute financially or through service to community outreach programs, all of which have contributed to its national reputation for excellence.

"When Hoag Orthopedics opened five years ago, we were not only given a great playground for innovation, but we orthopedic surgeons were also given an unprecedented opportunity to build it," says Alan Beyer, M.D., executive medical director of Hoag Orthopedic Institute. "We were eager to give back."

Carlos Prietto, M.D., president of Hoag Orthopedic Institute, adds that physician philanthropists at Hoag enjoy the unique opportunity to

**Ushering in the Future**

What really excites them is looking ahead. "The future of medicine is possible today with clinical trials and research partnerships funded entirely by philanthropy," says Dr. Beyer, who is the first Hoag physician recognized as a Hoag Benefactor for his cumulative donations.

Currently, Hoag Orthopedics physicians are collecting DNA data to study patient sensitivity to pain and how patients metabolize pain medication.

This clinical trial has the potential to seismically shift the way surgeons strategize patient diagnosis and treatment.

"This is breakthrough technology. When we're long gone, our young partners will be using this as part of their everyday practice," says Dr. Beyer.

Both Drs. Beyer and Prietto look back to their early mentors whose generosity and humility inspire them in the education of the new generation. What makes it particularly exciting for them is that through philanthropy, the future of medicine is already happening at Hoag.

be directly involved in the development, organization, budgeting and direction of research and education. "Many of us want to leave a legacy that will stand for many years to come and continue to drive a high level of orthopedic care to Orange County," he says. "There's a sense of ownership when you actively participate and financially contribute to these initiatives."

As a result, physicians have seen the tangible results of their generosity in everything from the dramatic decrease in readmissions due to infection, to the fifty percent increase in applicants to Sports Medicine, Total Joint Arthroplasty and Spine-Surgery Fellowship programs.

29th Annual Circle 1000 Founders' Celebration Brunch

The Circle 1000 Committee hosted its 29th Annual Founders' Celebration Brunch on May 9, 2016, raising \$840,000 for cancer care at Hoag. More than 350 Circle 1000 members, friends, physicians and nurses gathered to celebrate a legacy of service to individuals, families and caregivers affected by cancer.

"We are all touched by this disease and, as a member of Circle 1000 for more than 20 years, I'm proud that we have not only contributed to the growth of Hoag Family Cancer Institute, but that we have supported programs that help so many thrive after cancer," said Sheryl Anderson, chair. "Every year, my heart is deeply touched when we ask cancer survivors and caretakers to stand and be acknowledged. You can see that cancer does not discriminate and we have more work ahead of us to heal our family, friends and community."

Keynote speaker Shannon Miller is the only American to rank among the top 10 of all-time gymnasts and the only female athlete to be inducted into the US Olympic Hall of Fame twice. In 2011, Shannon was diagnosed with a rare form of ovarian cancer. She is currently cancer free

and continues to advocate for early detection. Shannon recently released her new book, *It's Not About Perfect: Competing for My Country and Fighting for My Life*.

"We cannot adequately describe the impact Circle 1000 has made on Hoag's standing as one of the top cancer institutions in Orange County," said Flynn A. Andrizzi, Ph.D., president, Hoag Hospital Foundation. "This extraordinary group of women has made it possible for Hoag to launch the Melanoma and Advanced Skin Cancer Program in alliance with USC Norris Comprehensive Cancer Center. Their dedication has also greatly contributed to the nurse navigator program and the availability of nursing scholarships as well as staff training and cancer research. 

# Laughing At Her Luck

Evelyn Hart Gives Back with a Grateful Heart

Evelyn Hart will be the first person to tell you she is the luckiest woman in Newport Beach. She counts her health, her family and friends, her beach house and her community on her gratitude list. Over the years, she has given much to the city that has blessed her with such a wonderful life.

She moved to Newport Beach in 1951 with her husband John. They worked side by side in the family business, Hart's Sporting Goods, located at Newport and Harbor Boulevards. "Everyone came to Hart's," she says. "Every now and then we run into old customers who tell us they still have the things they bought from us back in the day."

After twenty years in business, Evelyn and John closed Hart's. She had been involved with the City of Newport Beach Parks, Beaches & Recreation Commission, establishing the bike trails in the coastal areas and Irvine. In 1978, she decided to run for city council and, with the support of family and friends, she won a seat. For 16 years, including two as mayor, Evelyn stewarded the growth of Newport Beach.

"I've seen great changes here in Newport Beach, but one thing has remained the same," she says. "Hoag has always been here."

Two of her children were born at Hoag. Evelyn volunteered at the Hoag thrift store and worked on the hospital's call-waiting line. She was a long-time member of the Hoag Auxiliary and today, at the age of 85, remains active with the Oasis Senior Center in Corona del Mar. When she's not attending board meetings around town, Evelyn and John are on their boat or gardening.

### Stepping Up

Evelyn is forever grateful for the care and support she and her family have received from the physicians, nurses, staff and volunteers at Hoag over the years.

The advanced treatment from Hoag's Neurosciences Institute has kept her active and involved with life.

She credits Dr. Gwyn Parry, director of Hoag Community Benefit Program, and Flynn A. Andrizzi, Ph.D., president, Hoag Hospital Foundation, with providing philanthropic guidance. "When the Friends of the Oasis Senior Center needed to raise funds for a new building and transportation, they stepped right up and helped us," she says. "Dr. Andrizzi attends our meetings and helped us to get organized so we could meet the needs of our seniors."

Evelyn and John decided to name Hoag as a beneficiary of their trust so that no matter how much Newport Beach changes, Hoag will always be there for future generations.

"My gift is my way of saying thank you to the physicians and nurses and all who work to make Hoag what it is," she says. "Hoag has been so generous to Newport Beach and we can't help but think of it as our place."
